This Addendum consists of the Connecticut Resources Recovery Authority's ("CRRA") response to written questions submitted to CRRA by 3:00 p.m., Wednesday, March 30, 2011, the deadline for questions specified in the RFB Package Documents. The response to one of the questions has resulted in the revision of the "Bid Price and Delivery Timeframe Form" (Section 7 of the RFB Package Documents) and of the requirements related to the Bid Bond.

RESPONSES TO QUESTIONS

1.	Question	Please provide the number of hours you expect this machine to operate yearly. This is to help with Section 22.3 of the Technical Specifications Compliance Form and the Bid Price And Delivery Timeframe Form.
	Answer	<p>CRRA is considering two scenarios for use of the mobile grapple-crane. Under one scenario, the mobile grapple-crane will be used for approximately 1,500 hours per year. Under the other scenario, it will be used for approximately 4,000 hours per year.</p> <p>CRRA has decided to seek bid prices for both scenarios and has, therefore, revised the "Bid Price and Delivery Timeframe Form" (Section 7 of the RFB Package Documents) to provide for a bid price for each scenario. The revised form is attached to this Addendum. The revised form has also been posted in Word format on CRRA's web site at the same location where all of the other RFB Package Documents are posted.</p> <p>Section 14 of the "Instructions to Bidders" (Section 2 of the RFB Package Documents) requires that Bid Security in the amount of 10% of the amount of the bid price must be submitted with the bid. CRRA is hereby modifying that requirement. The amount of Bid Security must be 10% of the Alternate 1 bid price (Alternate 1 is the bid price with 1,500 hours of use per year).</p>
2.	Question	Is a bid bond required for this RFB?
	Answer	Yes. The Bid Bond Form is Section 4 of the RFB Package Documents.

1. BID PRICE

CRRA is considering two scenarios under which the mobile grapple-crane would be used. Under one scenario, the mobile grapple-crane would be used approximately 1,500 hours per year (Alternate 1). Under the other scenario, it would be used approximately 4,000 hours per year (Alternate 2). CRRA is seeking bid prices on both scenarios.

On a separate sheet of paper, each bidder must provide OEM and component manufacturer warranty allowable limits.

Bidder affirms that the total bid prices for Alternate 1 and Alternate 2 on the following page represents the entire cost to complete the Work in accordance with the Contract Documents, and that no claim will be made on account of any "overruns" (e.g., increase in wage scales, material prices, delivery delays, taxes, insurance, cost indexes or any other rates affecting the construction industry or this Project, etc.), and that each and every such claim is hereby expressly waived by Bidder.
