- SWMP has not been updated since 1991
- CRRA's future to crystallize around SWMP



- 900,000 tons of MSW imported in 1994
- 400,000 tons of MSW exported in 2005
- To address capacity shortfall:
 - Expand recycling to 50% by 2024
 - Exporting remainder



- CRRA supports recycling
- CRRA charges no tip fee for recyclables
 - Commodity sales generate revenue for projects
 - More recycling means fewer tons of MSW
 - Disposal fee savings



- Current recycling rate: 20-24%
- Increasing to 50% will need big investments
 - New infrastructure
 - Economic incentives
 - Public education campaign
- Rates stagnant for many years
- State will still need MSW disposal capacity



- Concerns about exporting
 - No guarantee in-state capacity will always be available
 - Would increase tonnage exported
 - No guarantee out-of-state capacity will be reliable
 - Transportation costs are volatile
 - Diesel emissions, odor problems, traffic congestion



- Benefits of trash-to-energy
 - Surpasses tough emissions standards
 - Green power for over 121,000 homes
 - Eases dependence on fossil fuels
 - Less imported oil
 - Reduces volume of landfilled waste by 90% to 95%
 - Keeps Connecticut self-sufficient



CRRA ash landfill siting study

 Expect to begin development in 2006



- CRRA expertise in building recycling infrastructure
 - Food waste and organics
 - Tires
 - Electronics
- Help towns maximize their recycling programs

New Hartford-Barkhamsted Suit


- Class certification hearing Feb. 27
- Only one other town has joined
- Others have decided against
- Suit has prevented CRRA from receiving other settlements
- Defense costs piling up
- Towns suing themselves

- Operational status
 - 92.5% boiler availability in 2005
 - 93.2% in 2004
 - Processed 716,000 tons in 2005
 - 725,000 in 2004
- Tip fee
 - FY 2007: \$70/ton + \$8/ton
 - FY 2006: \$66 + \$8




- Bridgeport Project expires Dec. 31, 2008
- CRRA negotiating new agreement with Wheelabrator
 - Authorized by project towns
- CRRA working to develop affordable options for towns




Project Reports Southeast Project

- Operational status
 - 96.6% boiler availability in 2005
 - 96.6% in 2004
 - Processed 254,000 tons in 2005
 - 262,000 in 2004
- Tip fee
 - FY 2007: \$60/ton
 - FY 2006: \$60/ton

Project Reports Wallingford Project


- Operational status
 - 91.8% boiler availability in 2005
 - 93% in 2004
 - Processed 143,000 tons in 2005
 - 146,000 in 2004
- Tip fee
 - FY 2007: \$58/ton
 - FY 2006: \$57/ton



Project Reports Wallingford Project

- Record-breaking electronics recycling events
 State needs comprehensive electronics program
- CRRA studying future options
 - Project expires in 2010
 - Power contract expires 2009







- Operational status
 - 88.4% boiler availability in 2005
 - 86% in 2004
 - Processed 821,000 tons in 2005
 - 809,000 in 2004



- Deliveries to Hartford landfill to end in 2008
- CRRA developing closure plan
- CRRA, City discussing closure, post-closure financing
 - May ask State Bond Commission
 - State money has helped close 28 smaller landfills
 - Benefits 70 towns



Odor control efforts succeeding

 Only one verified complaint in 2005



- New recycling contract
 - Adds junk mail/mixed paper
 - Revamped facility to expand recyclable menu by 2007
 - Boxboard
 - Oversized containers



MDC situation


- RFP process ended by board resolution



- Arbitrators decide for CRRA
 - MDC overcharges
 - Contractual right to bring in other contractors
 - Saving \$2.4m per year at transfer stations
- CRRA, MDC working on improving management oversight of contractor
 - Allow agencies to focus on serving their customers



CRRA Mid-Connecticut Project Tip Fee History Since Enron Bankruptcy





- Tip fee
 - FY 2005: \$70/ton
 - FY 2006: \$70/ton
 - FY 2007: Board to establish on Feb. 16
 - Management expects no more than \$70
